Research: Private motoring is mere expenditure – this is how much cycling and walking benefit the society. According to a recent study, cycling traffic generates 24 billion, and walking 66 billion worth of profit in the EU annually. (Against, 37 words)

The amount of emissions is the sum of many factors – Private motoring is partly blamed pointlessly. Private motoring does not generate more emissions than public transport per kilometre, when comparing travelled kilometres. The situation would be different if buses and trains were full of passenger at all hours and when travelling to both directions of their routes. (For, 57 words)

Opinion: Sitra's climate report wants to end free-time private motoring – goodbye to weekend trips to the cabin. According to Sitra's calculations, ending free-time private motoring would reduce the individual person's so called carbon footprint annually as much as by becoming vegan or by using wind power. (Against, 46 words)

Car use is also the favourite child of the taxman that is used when money is needed. The justification for car taxation is often environmental factors. (For, 58 words)

There are many reasons why private motoring would be banned if it were invented now. Private motoring is harmful in many ways but is hard to restrict since it is the people's right. Volvo has predicted that car use will become the chore of professional drivers, at least in cities, because privately owned cars are noisy and polluting. (Against, 58 words)

Only a few people make do in the countryside without their own car. Having one car per household is almost a must in small rural towns. The distances between towns alone are long. Work, hobbies and other everyday needs of families necessitate flexible transport. Alongside practical reasons, preferences speak for private motoring. (For, 52 words)

Comment: Think-tank spouted nonsense – objectors of private motoring forget many facts. In a sparsely populated country like Finland, private motoring is practically the only possible form of transport for about three million citizens, if we imagine that the rest two and a half million people happen to live in cities and work during office hours. (For, 55 words)
